
3. Qualification for membership Brief & Commitments

Founder Trustee: The Founder Trustee as mentioned in the Trust deed in the Settler of the Trust.



- (iii) The work of the Secretary shall be executive in nature & remain in charge of Treasurer of the Trust.


Financial Year: The financial year of the Trust shall be 1st Aril to 31st March.


